**“THE NEW RULE OF LAW IN CHINA.
CHALLENGES AND OPPORTUNITIES FOR THE ITALIAN SYSTEM”.**

IN 2013, TRADE WITH CHINA REACHED 32.9 BILLION EURO, AND IN 2014, EXPORT ROSE BY 8.3%. THESE ARE NUMBERS THAT INDICATE HOW MUCH CHINESE INVESTORS ARE CURRENTLY ATTRACTED BY OUR COUNTRY AND VICE VERSA. AN ECONOMIC DYNAMISM THAT HAS ALSO A GEOPOLITICAL DIMENSION SINCE NO OTHER COUNTRY BETTER THAN ITALY CAN REPRESENT THAT LOGISTIC AND INFRASTRUCTURAL BRIDGE INDISPENSABLE FOR A RECIPROCAL COMMERCIAL EXPANSION IN THE MEDITERRANEAN AND IN NORTH AFRICA:
